Outline of the Kata Examination in Bali 2024

The seminar and examination will have the following content and schedule.

- A. Main points of techniques (practical on tatami)
- B. Understanding of rules (paper exam)
- C. Scoring method (video exam).

Confirmation of movements and evaluation criteria. The main points of focus will be explained along with the model's performance on tatami mats. One hour for each kata. (Nage, Katame, Ju, Kime, Goshinjutsu)

Paper exam using the questionnaire method (English). Answers to questions on the scoring criteria will be given in the form kata of correct or incorrect answers. 20 questions per kata, 30 minutes.

Pass criteria: 14 or more correct answers: Pass

10-13 correct answers: Pass after re-test by oral examination

9 or fewer correct answers: Fail

Scoring Method. Scoring of past videos and comparison with own score to recognize the tendency of candidates' scoring. 2 videos of each kata.
